Bill Erikson HF Challenge

HF Challenge – the results are in!

Participants in the 2015 HF Challenge were recognized last month during FRRL's annual awards banquet. Everyone who participated in the Challenge received a handsome certificate commemorating their efforts.

Top operators were honored in each of the three main categories: Paul Fotre W9JML reported 71 contacts in the Limited Class; Roger Bara netted 229 contacts in the Operator Class; and Larry Stark K9ARZ earned 550 contacts in the QRO Class.

Of the 16 participants in last year's event, five also entered the optional Rag Chewer Class. Dick Illman AH6EZ/W7 reported 76 confirmed contacts, making him the top scoring entrant in that class.

Each of these participants received an attractive plaque commemorating their accomplishments.

The list of cosponsors for the US House version of the Amateur Radio Parity Act of 2015 (H.R. 1301) continues to grow. The addition of Rep Stevan Pearce, KG5KIQ (R-NM), and Rep Beto O'Rourke (D-TX) as cosponsors on February 1 raises the total to 120 cosponsors. They are among four cosponsors to sign on to the bill since the start of the year. The other two are Reps Robert Brady (D-PA) and Mary Kaptur (D-OH), who became cosponsors on January 12 and 13 respectively.

The ARRL Board of Directors has adopted an updated <u>Strategic Plan</u> that defines the League's vision and guides its direction over the next 5 years. ARRL COO Harold Kramer, WJ1B, a member of the Strategic Planning Working Group, said the revised plan represents more than 8 months of work on the part of the group's seven members. Now-Honorary ARRL Vice President Jim Fenstermaker, K9JF, chaired the panel, which met some 2 dozen times, mostly via webinar. Kramer said input to the Strategic Plan was considerable and comprehensive.
