# The Illinois QSO Party

Starting with the 2006 ILQP, the WIARC assumed the responsibility of sponsoring and administering this annual event. The ILQP takes place each October and involves amateur operators in all Illinois counties as well as operators from across the USA and in many foreign countries.

The QSO party provides Illinois operators the opportunity to be the 'rare ones' while providing stations outside of Illinois the opportunity to log many of the rarer Illinois counties. Illinois stations may operate as Fixed, Portable, Mobile or Rover stations.

High and Low power classes are provided for both Illinois Fixed and Non-Illinois stations and QRP competition is also provided.

**Date/Time:** 1700Z October 22 to 0100Z October 23,

2017

**Bands:** 160 through 2 meters, excluding 60, 30, 17, and 12 meters.

**Special band activity times:** IL stations are encouraged to spend some time on 20 meters in the early afternoon to work DX stations seeking IL counties and to check 15 meters and 10 meters at 1800Z, 1900Z and 2000Z.

# Bill Erikson HF Challenge

Congratulations to Challenge participant Larry K9ARZ, who reached another operating milestone last month! "The RI1ANO contact (reported in this update) was one of several that, with the help of Logbook of the World, allowed me to complete my DXCC on the 40 mtr band," he said. "The new Butternut vertical antenna was also a contributing factor." Other contacts included VK2 Australia (17M), A31 Tonga (17M), FK8 New Caledonia (17M), HK0 San Andres Isl. (20M), D2 Angola (40M), A25 Botwana (20M), S01 Western Sahara (40M), RI1ANO South Shetland Isl. (40M), JT5 Mongolia (20M), 5T2 Mauritania (40M), 3D2 Fiji (20M), 5W0 Samoa (20M).

"In between the solar flares and broken bands, the conditions have been slowly improving," Larry reported. "There have been several openings on 12 and 17 meters., and 40 meters has also improved somewhat."

Challenge Administrator Joe NA9A shared news of upcoming HF operating opportunities, including contests and DXpeditions. In his words:

"Tis the season to go after DX for the FRRL Challenge. Conditions are improving on 15 through 80 meters. Also with the CQ Worldwide (CQWW) SSB DX Contest coming 0000Z, Oct 28 to 2400Z, Oct 29, 2017, many DX stations are already getting on the air to check out their stations. A lot of the Challenge's asterisked countries are coming on, so go get them! The CQWW exchange is RS and CQ Zone (i.e. for us: 59 04)."

Upcoming DXpeditions Joe wanted to alert us to include:

VK9C\* - Cocos-Keeling will be on as VK9CZ with two stations, from October 24<sup>th</sup>-November 7<sup>th</sup>. They are taking 350 lbs. of equipment including Dean's and CJ's favorite IC-7300 rigs. They want to emphasize the lower frequency bands including 160.

- ZC4\* UK Sovereign Base Areas on Cyprus as G0KOM and his IC-706 will activate his G0KOM/ZC4MK callsign, inactive for 24 years. His low budget station will be active October 27-31, and maybe a few days more. When done, he will load contacts into LoTW and Club Log for quick QSLing.
- XW\* Laos will be on the air October 27-31 as XW4XR, primarily with our new mode FT8! Bruce Ault will be active from 60 through 6 meters, some impossible bands-except will they work with FT8. QSL by LoTW and watch for his spots.
- E4\* Palestine E44WE. Janusz (SP9FIH) says he will "probably" be on from (O Little Town of) Bethlehem between October 18 to 29. During CQWW, he'll stick to 15 meters, but outside of the contest, he will give us opportunities to get E4 on 30, 12 and 10 meters. Look for him on SSB, PSK and RTTY. Sorry, no LoTW, but OK Club Log for QSLs.
- A5\* Bhutan will be on as A52SJ October 12-19 and again October 26. Unfortunately for us, the operator Steve, N6SJ from Woodside CA will favor the west coast on 160 but maybe we'll have a shot on 20, 17 and 15. Not important to hams, it's still interesting that tiny South Asian Bhutan is notable for pioneering the concept of gross national happiness. What a concept!
- 9X\* Rwanda will be a challenge because Peter G4ENL is using a KX3 into an HLA300 amp and a Buddipole as 9XPJ/p. Soon he is moving to another location in Rwanda where he intends to add more antennas and work there until September 2018. Look for him on SSB 40-10 Meters.

As always, it's never too late to get in on the fun, and the fall season leaves many of us with more time for radio, so don't hesitate to send your questions or request a worksheet by emailing Challenge [at] frrl.org.

Well, hello fall. I hope that all of you have decided on your last minute antenna work before the weather changes in the next few weeks.

And thanks to this great weather we had an awesome time last weekend at the Scouting event called STEM O RAMA held at the Sandwich fair grounds. The Three Fires Council had asked our club to participate again this year and it was a lot of fun. We know there were about 3000 scouts there and we had a good number come out to see our operation. Dan WA9YKK, Dave W9BOO and myself along with Robert N9EF, Jack KC9RGW, Jon WA9JON and Bill Hollister K9WH put on an awesome showing of Amateur Radio.

One of the great highlights was watching the kids learning to send their names in Morse code. The look of success on their faces was priceless. As a reward for their efforts, we gave each person sending their mane a sticker that says, "I sent my Name with Morse Code". The stickers were loved by all. A big thanks goes out to Dan's wife Sally who performed the magic of making the stickers that we used. We will have to see if we get some new club members as a result of our STEM efforts.
