## **Bill Erikson HF Challenge**

The 2018 Bill Erickson HF Challenge is now underway! Challenge Administrator Joe Dubeck NA9A has mailed 2018 worksheets to all FRRL members, and announced that this year's event remains unchanged from last year's structure. Following is an overview of how the Challenge operates. Feel free to bring your questions to Joe at the monthly meeting, or via email to Challenge [at] frrl.org.

There are two ways to work the Challenge. You can opt to spread it out over the entire year, with the goal of working as many different states, provinces and DX entities as possible. This option works well for those with limited radio time. Those with more time can work the Challenge twice, giving them an opportunity to work each state, province and DX entity twice – once between January and June, and a second time from July through December.

**The Goal:** To contact as many of the states, provinces and DX entities as possible from Jan. 1 to Dec. 31, 2018. If you work the Challenge straight through the year, you can report one contact for each state, province and DX entity. If you work the Challenge as two parts (January through June and July through December), you can record two contacts with the same station or with two different stations in each state, province or country.

The Categories: Participants may enter the challenge in the following classes.

LIMITED CLASS is a niche for those who choose to operate within selected limitations, including CW only, QRP (5 watts or less), digital mode, or single band.

OPERATOR CLASS is for those making contacts with 250 watts of power or less, in any mode.

QRO CLASS is for those using any mode with any legal power output.

RAG CHEWER CLASS only counts contacts that last at least 10 minutes, in any mode.

**The Operation:** The purpose of the Bill Erickson HF Challenge is to stimulate operating activity. The main requirement, of course, is that you get on the air. Joe has made a point of keeping tabs on upcoming DXpeditions to help you contact some of the rare entities, so be sure to read each issue of the ArcOver for tips!

**The Reporting:** Part of the fun is seeing how other participants are doing throughout the year, so operators are encouraged to submit their total scores via email to challenge [at] frrl.org by the 20th of each month. Be sure your email includes your name and call sign, the class in which you are operating, and the total number each of states, provinces, and DX entities contacted. If you are also working the Rag Chewer Class, the total number of state, province, and DX rag chews should be reported. At the end of the year, your paper worksheet should be turned in to Joe NA9A.

**The Results:** More on-air activity! Joe emphasizes that the Challenge isn't a contest in the usual sense. Although a little friendly competition makes it more fun, the real purpose of this activity is to provide a framework within which to operate, so that more of us will get on the air more often and exercise the operating privileges we worked so hard to earn!

"In any class, just one contact on any HF band, in any mode, means you met the challenge," Joe wrote in the worksheet, "and you'll receive a beautiful certificate documenting your achievement."


Everyone who participates in the 2018 HF Challenge will be acknowledged and receive their certificates in January 2019.

# President's Traffic

I hope you all had a very happy New Year. I know that the temperature for most of us hasn't been the best, but now is the time to settle into a winter regime and start to make plans for the spring thaw. As I mentioned earlier, I am still searching for a good portable antenna that will give me the flexibility to work 80 through 10 meters in remote locations not conducive to ground radials. I have contacted Tom, N6BT who was the founder of FORCE 12 Antennas. He has started a new company featuring new antenna technology. I will let you all know what thoughts and products he might have. This past August I met some hams in DC, and several of them know Tom and speak highly about his antenna success. You can google N6BT and read about Tom. On another note, John KC9OJV sent out an email regarding a new battery technology called Lithium Iron Phosphate, or LiFePO 4. This is interesting technology in that it is safer than the Lithium Ion batteries that we have been using and the weight is significantly less than our standard sealed lead acid batteries. Like many of you, I have a battery pack that I use for portable operation. The unit is great, but it was so heavy with the Lead acid batteries. This past summer I replaced the batteries with LiFePO 4 and the weight reduction is significant. Due to their interesting discharge curve you can get away with batteries that have a smaller amp hour rating but they actually last longer at their specified output voltage according to the literature. I am including a 48 volt discharge curve just for your information. The experts indicate that the discharge curve looks like a hockey stick vs the normal sla battery curve.



Typical Discharge Curve Comparison

I am anxious to hear from John on what he discovers about LiFePO batteries so we can all learn about their safety, charging, discharging, use and longevity.
