The emergency communications response to the recent wave of severe thunderstorms and local tornado warnings by members of the Kane County ARES team was incredible in August. On Thursday the 23<sup>rd</sup>, a line of thunderstorms tore through our area during the mid-afternoon hours. FRRL member, and Emergency Coordinator for Kane County ARES, Eric KC9FQV activated the local Skywarn net using the County's 145.47 repeater. He, along with help from Cyd N9CV, also an FRRL member, did an outstanding job of handling storm related traffic from spotters throughout the county, many of whom are also FRRL and ARES members. Our communities are well served through the dedication of our fellow ham radio operators and the leadership of our ARES teams.

The September meeting is going to feature a "Leadership Roundtable" exercise. The FRRL Board of Directors will be discussing the future plans for our club and will actively solicit your input. As you have seen, our club has grown significantly this year. Several of our members have upgraded their licenses and have enjoyed their new operating privileges. A new D-Star repeater system has been installed due to the efforts of our Repeater Committee. Our Field Day exercise and the Hamfest were both very successful this year. All year our programs have centered around the new ham operator in support of the rule changes that went into effect. We welcome your comments and suggestions, that's why we will be devoting the September meeting to discuss ways to make our already great ham club even better. It will be a lot of fun!

You communication skills are needed this year during the 2<sup>nd</sup> Annual Huntley Fall Festival being held on the 15<sup>th</sup> of September at Deicke Park in Huntley. The event chairperson, Joe AB9OU with

assistance from Bill W9WRS needs your help. Bring your HT and a couple of charged battery packs. Joe needs help providing logistical communications support between park organizers and event coordinators. We will also be using APRS to track the event coordinator throughout the park.

The station will be set up in a prominent location on the park grounds to introduce ham radio to the public. A special QSL card will be available to all who make contact with the station. On September 5<sup>th</sup> the Gail Borden Library in Elgin will host an ARISS contact. John AG9D and myself have been working very hard as new ARISS Mentors to achieve a successful contact. The event will use the FRRL UHF repeater and the IRLP node to connect into the ARISS reflector. Anyone listening to the UHF repeater will be able to hear both the uplink from the library as well as the downlink from the ISS. Announcements about the contact will be made prior to the event on the UHF repeater. Astronaut Clay Anderson will be answering questions from Elgin School students. Children from the 2<sup>nd</sup> grade thru Junior High School have been selected to participate. #### **ARES News:**

Kane County ARES Supports MRC/Rescue Riders event — Annual Simulated Emergency Test postponed until October By Eric Lorenz, KC9FQV

Kane County ARES will be providing communications support for the Kane County Medical Reserve Corps /Rescue Riders "Ride For A Reason II" on Saturday, September 15<sup>th</sup>. They will be providing tactical and logistical communications between the ride's start point at the Kane County Health Department in Aurora and the 5 different venues that the riders will travel to. Ham Radio operators are needed for a variety of tasks, including setup, operating checkpoint stations, and shadowing ride officials. This will be a fun and educational event, as it will give operators experience in public service events as well as an introduction to the structure and operations of Kane County ARES.

Operators should have either an HT or mobile station capable of operation in either the 2m and/or the 440 band, or a portable station setup that can be deployed at a field site. Weather appropriate clothing is also encouraged, as well as a personal supply of water and a snack.

Due to the severe weather and flooding during the past few weeks, the decision was made to postpone the Annual Simulated Emergency Test until October. This even was originally planned to occur in conjunction with the Rescue Riders event. More information will be forthcoming as it becomes available.
