Please mark all changes, as the information on the form will be the basis for the 2007 Club Roster.

Annual Elections: Voting and Absentee Ballots

The FRRL Bylaws contain the following provisions concerning election of Officers and Directors:

Article VII — **Section 2. Election:** The annual election of all officers and the directors shall take place at the December meeting. The balloting shall allow for write-in names. A candidate shall be declared elected if that candidate receives the most votes cast by the members.

Article VII — **Section 3. Absentee Ballots:** Absentee ballots are allowed only for the election of officers and directors. The absentee ballot shall be prepared by the voter and delivered to any officer prior to the start of the meeting at which the annual election of officers and directors is held. All absentee ballots shall be drafted in ink. The office being voted on with the first and last names, or the Callsign of each candidate shall be listed on this ballot. The completed ballot shall be enclosed in a sealed envelope that is both printed and signed in ink using first and last name of the voter. The ballots shall be opened and tallied at the election.
