# Illinois QSO Party Rules

**Special band activity times:** IL stations are encouraged to spend some time on 20 meters in the early afternoon to work DX stations seeking IL counties and to check 15 meters and 10 meters at 1800Z, 1900Z and 2000Z.

**Exchange:** IL stations give RST and county; others give RST and state, province, or country.

**Scoring:** Count 1 point per phone QSO, 2 points per CW/digital QSO. No repeater QSOs. Stations may operate only one transmitter at a time. Stations may be worked once per band and mode (phone and CW/digital), and once per band/mode/county for IL Mobile and Rover stations. Each Mobile or Rover vehicle is considered one station and must use only one call. Contacts with/by stations at the border of 2 counties count as 2 counties and 2 QSOs; the border of 3 (or 4) counties count as 3 (or 4) counties and 3 (or 4) QSOs. IL stations multiply points by the sum of states, IL counties, VE provinces, and a maximum of 5 DXCC countries (W/K, Alaska, Hawaii and VE *excluded*). Count additional DX as points but not multipliers. Non-IL stations multiply points by number of IL counties worked.

### **Entry Classes:**

Illinois Fixed Station: Permanent station location, single county.

**Illinois Portable**: Not a permanent station location; antennas erected for the purpose of the contest; may be on a county line or corner.

**Illinois Mobile**: Stations capable of motion while operating though may be stationary. *Entrants are encouraged to utilize a separate driver and to choose operating procedures with safety uppermost in mind!* Mobile entrants may operate from only one county at a time. Simultaneous operation from more than one county will result in reclassification to "Rover" category.

**Illinois Rover:** Stations operating from more than one non-permanent location. Single county, county line and county corner operation is permitted. Any type of mobile or portable antennas may be used. Any power source may be used (auto, generator or commercial mains). Rover stations may operate while moving or stopped.

**Outside Illinois**: Any fixed, portable or mobile station operating from outside the state of Illinois.

**QRP Competition:** A QRP entrant shall certify that operation was with 5 watts or less at all times by checking the QRP box in the Entry Class column on the summary sheet. QRP stations should also indicate an Entry Class. QRP competition is independent of Entry Class.

### Awards:

**Plaques** will be awarded to the highest-scoring IL Fixed Station, IL Mobile, IL Rover, IL Portable, and Outside Illinois station. Plaques will also be awarded, regardless of entry class or station location, to the station reporting the highest raw Phone only QSO total, the highest raw CW only QSO total and the highest raw Mixed Mode QSO total. (Note: Illinois county line or county corner QSO multipliers do not apply for the raw QSO awards.)

**Certificates** will be awarded to the top 10 IL Fixed Stations, the top 5 IL Mobiles, the top 5 IL Rovers, the top IL and Outside Illinois QRP stations, and the highest scoring station (reporting at least 25 IL contacts) in each state, province, and country. Certificates will be awarded to the top 3 IL single county Portables, the top 3 two county line Portables, the top 3 three county line Portables and the top 3 four county line Portables.

**Illinois Club Competition:** Illinois entrants are encouraged to include the name of their local club on their entries. A traveling plaque sponsored by the Western Illinois Amateur Radio Club will be given for the top IL club aggregate score.

**Illinois Edible Award:** Any Outside Illinois operator who makes at least 200 IL QSOs or works at least 75 IL counties will receive an "Illinois Edible Award".

**Logs:** Entrants who use computerized logging programs are requested to submit logs in electronic format. Do not submit computer printed log from a logging program without also submitting the electronic file (i.e. Cabrillo file) as the scoring and verification process starts by transferring all log data into a master Excel file. Hand written paper logs which are accompanied by a completed ILQP Summary Sheet will be accepted for manual transcription by the Committee.

**Electronic logs:** Cabrillo format is preferred. Those entrants using a program that does not produce a Cabrillo file for submission should contact the ILQP Contest Committee concerning acceptable formatting. Electronic logs should be sent as an e-mail attachment to n9jf@arrl.net. Participants without e-mail access wishing to submit an electronic log should send the Cabrillo file on a DOS formatted 3-1/2 inch floppy disk or 5 inch CD-ROM by mail. Disks should be mailed to WIARC, P.O. Box 3132, Quincy IL 62305-3132. Disks will not be returned unless accompanied by an SAE with sufficient return postage.

**Paper logs:** A paper log may be hand written and must indicate the entrant's QTH, the band and mode, UTC, the call of the station worked, RST sent and received, and the state, province, IL county, or DX country. By submitting a hand written log, entrants agree to accept the Committees interpretation and transcription of the log data. New multipliers must be marked in the log. Any station with over 100 QSOs must submit a dupe sheet. Mobile and Rover entries send dupe sheet only for counties from which you make 100 or more contacts. Paper log submissions must be accompanied by a properly completed ILQP summary sheet. Paper logs should be mailed to WIARC, P.O. Box 3132, Quincy IL 62305-3132.

# Logs that do not comply with submission requirements will be classified as Check Logs and will not be eligible for awards.

**Submission deadline:** Logs sent by e-mail must be received by and logs sent by mail must be postmarked by midnight (CST) November 20, 2013. A list of all logs received will be posted to the ILQP Reflector prior to the deadline. Electronic logs received by e-mail will also be acknowledged by return e-mail. Entrants assume responsibility for contacting the event sponsor if they do not receive confirmation or if their call is not included in the "logs received" listing.

**Disqualification:** Participants are expected to follow good Amateur practices and operate within the restrictions of their license and in accordance with ILQP Rules. Compelling evidence to the contrary may serve as grounds for disqualification. The decision of the Illinois QSO Party Committee shall be final. Last weekend, the W9DXCC event far exceeded my expectations. If you did not attend, mark your calendar for next September. "DX University" was exceptionally good. There was a lot to learn, even if you are a seasoned DXer. The main event included presentations of notable DXpeditions by one or more of the crew involved. The banquet speaker was Dr. Joe Taylor, K1JT, who gave some interesting background about key issues in his development of WSJT. ICOM, Kenwood, Yaesu, and Ham Radio Deluxe people were there both days. NIDXA did a great job. Their chair this year was Kermit, W9XA. Thank you, Kermit!

October means we are starting membership renewal at the meeting. Please bring a check and get that item over with.

Now would be a good time to check your antenna systems before the weather turns bad. Although, they say an antenna installed or repaired in the middle of winter performs extremely well.

The first day of the FRRL - General Class license course was just this last weekend. Quite a few students are off to a good start. Ron tells me all the instructors are ready to go! We will ship all the students to our VE group afterwards.

I just wrapped up another QRP two hour sprint called "Peanut Power." It was a lot of fun. You know – whether you are thinking about working DX, contests, rag chews, or other activity ---- The important thing is: Get on the air!

### Regulatory: FCC -- "We Regret the Disruption." Commission Shutdown Complete

The FCC appears to have ground to a complete halt for all intents and purposes beyond emergencies, as the Federal Government shutdown continues. This includes functions at the Commission's Gettysburg, Pennsylvania, facility, which handles all Amateur Radio licensing transactions, as well as the FCC's main website and the Amateur Radio call sign database (ULS).

"We regret the disruption, but during the Federal Government-wide shutdown, the FCC is limited to performing duties that are immediately necessary for the safety of life or the protection of property." a message on the FCC website says. "FCC online systems will not be available until further notice." The Commission refers anyone calling regarding an emergency "affecting the safety of life or the protection of property" to a Washington, DC, number, 202-418-1122, or an e-mail address.

Assistant ARRL VEC Manager Perry Green, WY1O, said October 1 that the FCC appeared to have accepted "a small number" of modification and renewal applications, apparently as the shutdown was in process, but it took "far longer than usual" for that to happen. The ARRL VEC did not attempt to file additional applications, and it will hold for filing any applications resulting from Amateur Radio Volunteer Examiner-administered examination sessions.

"We have not submitted any VE sessions, which require batch filing and are assigned an FCC filing number," Green added. "At this point, we are unable to file any applications with the FCC, because it has shut down its servers. We do not expect the FCC to resume granting applications until it reopens." Green stressed that the ARRL VEC remains open for business and continues to monitor the situation. The ARRL VEC also is still processing International Amateur Radio Permit (IARP) applications.

While the FCC has stopped processing new, renewal or vanity call sign applications for the duration, it is still possible to reserve a 1 × 1 special event call sign, since that is not an FCC function. Green points out that ARRL VEC exam sessions will go on as scheduled, at the option of the sponsors, but the ARRL VEC will not be able to file session paperwork for processing until the shutdown ends and the FCC is back in business again. Green notes that exam session candidates have to put an FCC Registration Number (FRN) on their applications, if they have one. FRNs for current licensees are available via the ARRL's "Call Sign/Name Search" utility on the League's home page. If the FRN is not available or has not yet been issued, applicants may use their Social Security numbers, which candidates must provide to obtain an FRN. "So in this time of shutdown, they will need to submit their SSN on the VE session paperwork and gain their password at a later time," Green explained. "If that is not to their liking, they will have to wait for the FCC to open up again, which I'm sure at some time it will."

Radio amateurs whose licenses expire between October 1 and the day after normal FCC operations resume may continue to operate until then, even if they have not yet filed a renewal application. Pending an official FCC announcement that states otherwise, renewal applicants should apply no later than one day after the FCC reopens, if they want to continue to operate. Amateur Radio applicants who passed an upgrade examination may still operate with their new privileges, even if their applications have not been accepted for filing by the FCC. Applicants must have a Certificate of Completion of Examination (CSCE), issued by the VE team. When using their new privileges, such applicants should continue to identify by appending the appropriate designator to their current call signs, ie, /KT for Technician, /AG for General and / AE for Amateur Extra. as noted on the back of the CSCE.
