Very few updates were received for August, presumably due to poor propagation conditions. Even the most active DXers participating in the Challenge reported no rare entities and only the most modest of gains in their overall scores.

Larry K9ARZ said there wasn't much activity on the bands except for 20 meters.

"Even working the states is a challenge," he said. "I'm looking forward to improved conditions this autumn and upcoming DXpeditions."

For those new to working the HF bands, keeping tabs on solar activity can help you understand how space weather conditions are adversely affecting your radio communications, and also lets you take advantage of conditions that enhance propagation. Current solar indices can be found at <u>www.dx.qsl.net/propagation</u>. ARRL also publishes a daily propagation bulletin, and offers numerous articles on the sun's effect on propagation; go to <u>www.arrl.org/</u> <u>propagation</u> for links to this material.

FCC website maintenance in early September will make the Universal Licensing System (ULS), the Electronic Comment Filing System (ECFS), the Electronic Document Management System (EDOCS), and other public applications unavailable for more than 5 days. The Commission said the outage will begin at 2200 UTC on Wednesday, September 2, and continue through the Labor Day weekend. The maintenance work should be completed by 1200 UTC on Tuesday, September 8. During the ULS outage, it will not be possible to file any Amateur Radio applications.

Two incumbents face challenges in the 2015 election cycle for ARRL Director and Vice Director. Both races are in the ARRL Northwestern Division. Incumbent Director James Pace, K7CEX, of Centralia, Washington, will face a challenge from William Balzarini, KL7BB, of Auburn, Washington. Delvin Bunton, N7QMT, of Vancouver, Washington, is seeking to unseat Northwestern Division Vice Director Bonnie Altus, AB7ZQ, of Sheridan, Oregon.

The ARRL Ethics and Elections Committee earlier determined all candidates for the 2016-2018 term in this year's election cycle to be eligible and nominated.

Incumbents in four other ARRL Divisions faced no challengers in



the current election cycle and have been declared re-elected. They are Central Division Director Dick Isely, W9GIG, and Vice Di-AMATEUR RADIO rector Kermit Carlson, W9XA; Hudson Division Director Mike Lisenco, N2YBB, and Vice Director Bill Hudzik, W2UDT; New

England Division Director Tom Frenaye, K1KI, and Vice Director Mike Raisbeck, K1TWF, and Roanoke Division Director Dr Jim Boehner, N2ZZ, and Vice Director Bill Morine, N2COP.

Ballots will be mailed on October 1 to ARRL members in good standing in the Northwestern Division as of September 10, 2015. Ballots will be counted under the supervision of an independent auditor, and the successful candidates will be announced on November 20.

The Ethics and Elections Committee agreed in January to return to using solely paper ballots, after instituting a hybrid paper and electronic balloting process in the autumn of 2012. Online balloting proved popular among those who took advantage of it, but overall voter participation declined significantly. See August 2015 QST, p 78, for more information.

President's Traffic

"I am just an egg," I commented to a friend the other day. We were discussing computer technology that I'm in the early stages of grasping. That phrase, from Heinlein's *Stranger in a Strange Land*, just popped out, so I was utterly surprised when my friend replied, "I grok."

To grok, another Heinlein term, is to understand at the deepest level. Many of you grok radio technology, for example, an accomplishment that speaks to hard work and years of experience. Others are in a much earlier stage of learning; they're "just eggs" in Heinlein's parlance, growing in understanding through consistent immersion.

One thing I have always loved about FRRL is the way embrace our "eggs" – those who are striving to become what many of you already are. Newly licensed? No problem, we'll show you how to operate. New to electronics? Great, we'll teach you the theory behind it. New to the world? Awesome, we especially love sharing our knowledge with youngsters! Within our ranks, those who grok are the most generous of Elmers.

But wherever you are in your learning journey, your contributions are not limited by how much you know. Especially in a field where the technology is evolving at an unprecedented rate, there is always something new to learn, a fact that should keep us humble, even as our years in the hobby grow. And by the same token, no matter how new you are to radio, you undoubtedly have acquired other skills that position you to make a unique contribution to the state and progress of the club.

I mention this now, as summer cedes to fall and we begin making plans for the coming year, because it's a really good time for each of us to reflect on what we have to offer. Not least among our immediate tasks is setting this year's Nominating Committee to work. They'll be seeking candidates to run for officer and director positions. Have you considered what you might have to offer in that capacity? Have you thought, over the years, about what those in office have done well, and what you might have done differently if given the chance? Perhaps the time wasn't right for you to step forward in the past; but a new day is dawning, and just maybe your time has come.

We also need to fill the chairperson spots for our two major events, Field Day and Hamfest. Neither of these positions requires you to reinvent those activities – although new ideas and improvements are certainly not discouraged! – and the new chair people will be given detailed instructions on what needs to be done to create a successful event.

Beyond that, you will be electing a new president for 2016, whose privilege it is to recruit and present to the Board for approval the individuals who will handle key functions for the club throughout his or her term.

It has been one of the principles on which I've directed my actions while serving as your president: *everyone* has something to offer. The only difference is the form that your "something" takes. Some of us have strong leadership skills; some have a powerful impact behind the scenes. Some are detail-oriented; some excel at seeing a bigger picture. Whatever your capabilities, length of time in the hobby, or years of membership in FRRL, I do hope you will consider how you might make a difference in the club in the coming year.

Although I volunteered for jobs within my comfort zone, I didn't quite understand this principle during my early years in the club. I thought I would make a greater contribution down the line, after I'd gained more technical acumen. But a friend and former FRRL president thought differently, encouraging me to run for a director seat – probably years before I might have considered it on my own. I thought deeply about the ways I might serve this club that I love, and suddenly it made sense to step out of my comfort zone. Whether you're an "egg" like I was, an experienced ham, or somewhere in between, I encourage you to begin thinking about what you have to offer. Let me or any of your Board members know that you'd like to help make a difference.

No matter how big or how small your contributions, and no matter how many or few years you have under your belt, your efforts will help shape and give momentum to the future of FRRL. Everyone has something to offer; it's just a matter of choosing to make it happen.

I finally grok that concept. How about you?
