**Minutes of the Regular Meeting of the General Membership of the
Fox River Radio League (FRRL) an Illinois not-for-profit Corporation
Held at St. Rita of Cascia, Aurora, IL**

Meeting Minutes October 11, 2011

The meeting was called to order at 7:35 PM by John Spasojevich AG9D– President.

- **Secretary's Report** - John AG9D announced that copies of the meeting minutes for the September 13, 2011 Regular Meeting are available from FRRL Secretary, Ron KC9SNI. Ken K9WCX motioned to accept the minutes, which was seconded by Denny W9HI. The motion carried.

Unfinished (Old) Business - There was no unfinished business from the September 13 General Membership Meeting.

New Business – Randolph W9HE motioned to increase member dues by \$15 in lieu of the Hamfest. The motion was seconded, and discussion of the motion proceeded.

Many points of view regarding the Hamfest including its benefits, drawbacks, and revenue were expressed by the members present. While it was noted that attendance at almost all hamfests has been declining, it was also observed that hamfests provide important social benefits to attendees plus a venue for the exchange of equipment and technological information.

Regarding revenue it was noted that, in addition to gate ticket and vendor table sales, Hamfest revenue has included advance ticket sales to club members. Traditionally, members have been expected to purchase six tickets at \$5 each for their own use or resale. Since the apportioned fixed costs of Hamfest operations amount to approximately \$15 for the \$30 garnered from advance ticket purchases by members, the net revenue to the club is about \$15.

Randolph W9HE clarified it was his intent that the proposed \$15 hamfest replacement fee be handled in a manner similar to the Repeater Fund and thus be separate from member dues.

Due to the complexity of the issues, the possible ramifications ensuing from this motion, and thus the need for continued discussion, Dick W9GIG motioned that this be tabled until the next month's General Membership Meeting. Kermit W9XA seconded the motion. John AG9D called for a vote from the attending members, and the motion to table carried.

- **Committee Reports:**

Banquet – Mike K9FE reported that a location for the annual banquet has not yet been booked, although last year's location is still under consideration. Mike conducted an informal poll of attendees asking "How many would like to continue with door prizes at the banquet?" A minority indicated support. He further asked "How many want to go to the same place?" Again, few indicated support. He also stated that the banquet would be held on the same Saturday in January as last year.

Education – Eric AB9OS reported that the next Technician license class will commence on October 15. A General license class is planned for the first quarter of next year. Dick W9GIG presented three ARRL course manuals to Eric for use in these classes.

Newsletter – John AG9D reminded that any material intended for *ArcOver* be submitted to the Editor, Tobi K9TCD, by the 20th of each month.

Nominating Committee – Kermit W9XA, Chair, reported that the committee, which includes Vicki KC9PWM and Bill WB9LPW, is in the process of identifying nominees to fill upcoming vacancies for club officers and directors. He asked that members interested in running for any of these club leadership positions to contact him.

Program – Kermit W9XA, in his capacity as Vice-Director of the ARRL Central Division, reported that he would at this meeting provide a briefing on current ARRL matters and present a quick tour of ARRL headquarters.

VE Session – John AG9D stated that the next Volunteer Examination session is scheduled for Tuesday, November 15. Doug W9RD is the VE Team Leader.

SDR SIG – Harry K9DXA announced that the Software-Defined Radio (SDR) SIG will recommence at Rasmussen College on Saturday, October 22 at 9 AM and continue on November 12th and December 10th.

With no further business, a motion to adjourn was made by Ken N9WCX and seconded by Randolph W9HE. The motion carried, and the meeting adjourned at 8:36 PM.

FRRL and St. Rita Church Move Forward With Campus Plans

On October 22, 2011, FRRL members spent several hours at the St. Rita Church campus to work on two projects discussed with Fr. Cesar, during a meeting on October 19 with several Board of Director members. These projects involve FRRL bringing Wi-Fi internet to the Church basement, and helping Fr. Cesar set up a 2M base station in his office.

Dick AH6EZ located resources to tie in to an existing high speed internet connection point in the Parish Center, route the wire signal cable to a “Canopy” transceiver beamed to another across the lawn, located near the entrance to the Church. The second “Canopy” was then connected to an indoor mounted Wi-Fi AP via wire signal cable. Dick located all necessary parts and took charge of the installation. He had help from Jeff N9JZN, Larry K9ARZ, Dawn KC9LQS, Dean KC9EOQ, and Harry K9DXA. Dean used a laptop to test the system and lock down the Wi-Fi AP. Dick is now working on ideas to use this new found resource to enhance his meeting programs.

Larry strapped on his trusty climbing belt and took off for the top of the existing tower behind the Parish Center building. He removed a rotator and TV antenna, and mounted a Ringo 2M vertical, complete with RG213 coax. We’ll talk with Fr. Cesar again to determine the coax routing between the tower and his office. Then he will locate his ICOM base rig and check in on the W9CEQ repeater. So please expect him to be checking in shortly.

Further plans are underway to provide additional enhancements for Parish members as well as for FRRL members visiting St. Rita campus for meetings.

About the FRRL

The Fox River Radio League, Inc., is a general interest amateur radio club serving the central Fox River Valley area. Records indicate the club has been in existence since at least 1924, and has functioned continuously ever since.
