President's Traffic

Field Day! Yes, it's June and that means our annual Field Day event is back, and it's bigger and better than ever!

We have a new site this year, the FOP Lodge at the corner of Hwy. 47 and Kedeka Road, on the edge of Bliss Woods Forest Preserve, north of Sugar Grove. A special thanks to Dean KC9EOQ and Dave N9CTO for securing the property for our use.

Our Field Day Chairperson, Charles KC9DAO has several new plans for this year's event, including a welcome area and information center, the GOTA station location at the entrance of the Lodge, a ham radio history area and a new site plan keeping all stations centrally located for easy access.

If you're new to ham radio, and several of our members are, Field Day is an ARRL sponsored event. It was originally conceived to determine our level of emergency preparedness in times of communication crisis. It has evolved into an operating event, a social event, a contest, an emergency response event, and a teaching and learning opportunity.

This year we will operate as 8A, eight stations on the air using emergency power (generator). Let me introduce your band captains: 80/15 CW is being headed by Harry K9DXA. Harry has rediscovered the hobby and is a good CW operator. You will find him to be very inviting, and anxious for your help. 40 CW band captain is Tom WB9CHY. Tom runs a very nice station, and will need your help installing his antennas. Tobi N9TCD who is also responsible for our NextGen Hams youth activities is Tom's wife. She likes to hang out at some of the phone stations to make

Q's (contacts). Our 20 CW station is being set up by Larry W9OKI. Larry has lots of experience and likes to get other CW ops at his station. In the past the CW guys have added greatly to our point totals.

The 80/15 phone station is being set up by members of our Kane County ARES team, Eric KC9FQV and Dave N9CTO. They will have the St. Charles Red Cross communications trailer at their disposal this year. These dedicated individuals are very friendly and welcome the opportunity to set up their gear and get on the air. 40 phone is being set up by one of our most experienced hams, Mike K9FE. I'm sure Mike would appreciate your help during set up, operation and take down. He continues to be a valuable member of the club by offering his technical expertise to new hams. 20 phone band captain is Dick AH6EZ. Over the years Dick has built and used many home-brew antennas. He takes the time to design and build his FD antennas before hand to prove out their effectiveness. Dick really enjoys FD and likes to experiment. He is one of the motivating forces in the club and continues to assist everyone during the event. N9CHA visits K9LU in Alaska

Do you remember the excellent program put on by Lou K9LU and his wife Val KC9HRK in January? Well I sure do, and it rekindled my desire to visit Alaska, a dream of mine since I was 6 years old.

On March 27th, 1964 the Good Friday Earthquake hit southern Alaska near College Fjord in Prince William Sound. The Pacific and North American plates collided and created one of the most devastating events of the modern era, lasting for up to 5 minutes, and causing huge tsunamis killing 131 people.

A young man my age, Lance, was living in Anchorage at the time. He and his family were severely affected by the earthquake forcing them to leave Alaska and live with family members in Wisconsin until they could rebuild. It was not until later in 1964 that I met Lance in 1st Grade at Longfellow Elementary School in Wausau. He was a very shy boy, but some of us made friends with him and got him involved with school activities. I remember his father coming to visit our school and explained what had happened to his family. He brought along newspapers that had photos of some of the damaged streets, businesses and houses in Anchorage.

Ever since then, when anyone spoke about Alaska, or I would see something on TV about the state, I would remember my encounter with Lance and his family. Later in my life I looked at pictures and films of the awesome beauty of the landscapes and vowed to sometime visit. This past January the pictures and events shown and told to us by Lou and Val ignited a spark in me to make the journey this year. Alaska will celebrate it's 50th year of statehood next year, and I turned 50 this year... so off I went with my friend and business partner Kathy N9DEE for a week-long vacation.

We landed in Anchorage after a 5 1/2 hour flight from Minneapolis. This time of year the sun never really sets, so it was somewhat difficult to acclimate to the high sun angle at 11 pm. When I was planning for this trip I organized a "to-go" kit of ham radio equipment. I bought an Icom IC-7000; received a new LDG auto-tuner for my birthday, and put together a 40 and 20 meter dipole to take with me. However, after looking at propagation near the 60 degree parallel, I decided not to take my kit, and only took my handi-talkie and a mag-mount antenna. I soon learned that nearly all of the Anchorage repeaters are permanently hooked up to an IRLP reflector, making direct connections impossible. I did receive a call from Dick AH6EZ who connected with the reflector, and later with my brother Glen KE7FZX who did the same.

Monday the 19th we drove to Wasilla, a thriving community about 50 miles north of Anchorage on the Parks Highway where Lou and Val have their trailer. Lou and I had coordinated our arrival using 146.52 simplex just in case I had the directions wrong. Lou talked us in just fine and after a nice hour long visit, we set out to get some lunch and see the sights. Wasilla is growing and currently has most of the chain stores we enjoy here. It's amazing to see a Wal-Mart, Home Depot and other big-box stores set up along the highway just like Randal Road!

I asked Lou if we could visit Gary AL9A's home. Gary was not at home unfortunately. If you've ever seen Gary's QSL card, you know why I wanted to visit. Gary has helped us (W9BHB Club) out with an IRLP contact in the past and has described his wonderful location. I just needed to see it to believe it... and it's just as beautiful if not more so!

After talking to Lou about HF, he informed me that the absorption at the high latitude made it nearly impossible to make contacts on a regular basis. With patience and proper band conditions it is possible but hard to do.

Alaska is a beautiful state with lots to offer. The short week-long visit made me wanting to go back, perhaps during the high peak of the next solar cycle. This trip I did see Mt. McKinley from Talkeetna, and Turnaround Arm from Girdwood, the Port of Seward and Resurrection Bay, and the Portage Glacier. Lou and Val will return later this year. They have many more stories to tell about their year-long adventure... and I can't wait to see and hear them!


